Resolution 2005-11  
 Lincoln County GIS Fee Structure

**WHEREAS**, The Board of County Commissioners in and for Lincoln County, Wyoming, may regulate, restrict the distribution of Geographic Information Systems data created and maintained by Lincoln County; and

**WHEREAS**, the Board of County Commissioners find that costs in administration and development of the Lincoln County GIS have increased significantly; and

**WHEREAS**, the Lincoln County Office of Planning and Development and the Lincoln County Assessor's Office have recommended that the GIS Fee Structure be adjusted; and

**WHEREAS**, the Board of County Commissioners has reviewed the recommendations of the Lincoln County Office of Planning and Development and the Lincoln County Assessor's Office; and

**WHEREAS**, the Board of County Commissioners want to maintain free sharing of Lincoln County GIS data with other Government entities, Educational entities and Cooperating Public Utilities under certain restrictions,

**THEREFORE**, let it be known that after careful consideration and due deliberation, the Board of County Commissioners of Lincoln County, Wyoming Does adopt the following Lincoln County GIS Fee Structure to be administered by the Lincoln County GIS Coordinator while still maintaining free sharing of Lincoln County GIS data with other Government entities, Educational entities and Cooperating Public Utilities under the agreement that each entity will agree to work within the restrictions distributed with the data:

Complete Parcels layer	\$500.00
Complete Update to Previously Purchased Parcels layer	\$250.00
Single Township & Range of Parcels layer	\$5.00
Complete Roads layer	\$200.00
Complete Update to Previously Purchased Roads layer	\$100.00
All other Lincoln County GIS layers	\$50.00/layer
Minimum Cost per Request	\$30.00
