Cokeville Election District No. 2

Polling Precinct No. 9

All of that part of Lincoln County bounded and described as follows:

Bounded on the North by the line between T28N and T29N; and

On the East and South by the following described line: Beginning at the northeast corner of Section 3, T28N, R118W where it meets T29N and proceeding southerly along that section boundary until that point at the southeast corner of Section 34, T26N, R118W. Then easterly along the section and township boundary until that point at the northeast corner of Section 35, T25.5N, R118W. Then southerly along the section boundary until that point at the northeast corner of Section 2, T25N, R118W. Then southerly along the section boundary until that point at the northeast corner of Section 14, T25N, R118W. Then easterly along the section boundary until that point at the northeast corner of Section 13, T25N, R118W. Then southerly along the section and range boundary until that point at the southeast corner of Section 36, T25N, R118W which is also the point at the southeast corner of T25N, R118W. Then westerly along the section and township boundary until that point at the northeast corner of Section 1, T24N, R119W. Then southerly along the section and range boundary until a point at the intersection of the US Highway 30 centerline and the east section line of the SE ¼ of Section 1, 21N R119W. Then westerly along the centerline of US Highway 30 to the intersection of US Highway 30 and Wyoming Highway 89, known as Sage Junction.
