 BOARD OF LINCOLN COUNTY COMMISSIONERS
 May 20, 2014

Chairman Wolfley called the meeting to order at 9:00 a.m. Others in attendance included the following: Commissioners Connelly and Jenkins; County Clerk, Jeanne Wagner; County Attorney, Josh Smith and Commissioner’s Secretary, Corey Roberts. Chairman Wolfley was excused from the meeting at 1:41 p.m.

- Consent Items:** **1.** Commissioner Jenkins moved to approve the consent items. Motion was adopted. **2.** Commissioner Connelly moved for the Chairman to sign the Veteran’s Service Office agreement between Lincoln, Sublette, and Sweetwater counties for one year. Motion was adopted. **3.** Commissioner Jenkins moved to approve the vouchers. Motion was adopted. **4.** Commissioner Jenkins moved to accept Mt. State Water Services, Inc. bid in the amount of \$483,674.79 with the required information and allow the Chairman to sign the contract. Motion was adopted. **5.** Commissioner Connelly moved for the Chairman to sign the road right of way license with the BLM on Gomer Road – #338 and Graham Lane – #310. Motion was adopted. **6.** Commissioner Jenkins moved to sign the resolution establishing the salaries of the elected officials within the county of Lincoln and state of Wyoming; the annual salaries of the County Commissioners elected in 2014 - \$39,812 for 4 years; County Clerk, County Treasurer, County Assessor, and Clerk of District Court - \$68,797 for 2 years and \$72, 500 for 2 years; County Sheriff - \$73,993 for 2 years and \$80,000 for 2 years; County Attorney - \$93,000 for 4 years. Motion was adopted with Commissioner Connelly voting no.
