BOARD OF LINCOLN COUNTY COMMISSIONERS  
**November 17, 2015**

Chairman Harmon called the meeting to order at 10:00 a.m. Others in attendance included the following: Commissioner Connelly; April Brunski, Deputy County Clerk; Josh Smith, County Attorney; Corey Roberts, Commissioner’s Secretary. Commissioner King was absent from the meeting to attend Tour 23.

**Consent Items:** **1. Commissioner Connelly** moved to approve the consent items. Motion was adopted. **2. Commissioner Connelly** moved to approve the grant award agreement with Wyoming Homeland Security in the amount of \$24,285 for portable radios. Motion was adopted. **3. Commissioner Connelly** moved to approve the Resolution for Reassignment of Consensus Block Grant with the Town of Cokeville to upgrade telemetry system for the water & sewer system. Motion adopted. **4. Commissioner Connelly** moved to approve the renewal of the following retail, malt beverage, restaurant and microbrewery liquor licenses/permits: Nordic Inn LLC-Stag Bar; Reel Adventures LLC-Silver Stream Lodge; Ridge Creek Inv. Co.-Flying Saddle Lodge; Boardwalk Dev. Group LLC-Ridge Rider Lounge; Boardwalk Market LLC-Nordic Market; Michael D. Marble-Fontenelle Store; Garland Etc. LLC-Etna Trading Co.; Cakebread Ranch LLC-Cakebread Ranch; OYG Catering, LLC-Old Yellowstone Garage; Jackson Hole Brewing Co. LLC and Melvin Brewing Company, LLC. Motion adopted. **5. Commissioner Connelly** moved to approve the vouchers for the day. Motion was adopted.

County Engineer, Amy Butler**-update on the new Road & Bridge shop, Shute Creek CR340 re-alignment, McNeel Powerplant CR104 ownership & easement, Hams Fork CR305 snowmobile parking area, Strawberry Creek CR126 concerns with layout of ROW & easements **4. County Sheriff, Shane Johnson**-inmate medical, forest service law enforcement **5. South Lincoln Medical Center Clinic Director, Scott Erickson**-agency overview and answered questions from the Commission, Title 25 discussion **6.
