

**OFFICIAL PROCEEDINGS**  
**BOARD OF LINCOLN COUNTY COMMISSIONERS**  
**September 20, 2016**

Chairman Harmon called the meeting to order at 10:00 a.m. Others in attendance included the following: Commissioners Connelly and King; County Clerk, Jeanne Wagner and Commissioner's Secretary, Corey Roberts.

**Consent Items:** **1. Commissioner King** moved to approve the consent items. Motion was adopted. **2. Commissioner Connelly** moved for the Chairman to sign amendment #3 in the amount of \$41,003.38 between Lincoln County and Fiber Tel to install fiber to the library in Kemmerer. Motion was adopted. **3. Commissioner King** moved to rescind the fire closure by Wyoming Statute 35-9-301. Motion was adopted. **4. Commissioner Connelly** moved to pay the vouchers. Motion was adopted. **5. Commissioner King** moved to go into Executive Session at 10:59 a.m. with Dennis Tester of the Western Wyoming Gun Club in regards to property. Motion was adopted. **Commissioner Connelly** moved to return to Regular Session at 11:30 a.m. **6. Commissioner Connelly** moved to sign the agreement with Family Services on the TANF grant in the amount of \$43,500. Motion was adopted. **7. Commissioner King** moved for the Chairman to sign the fire protection service contract with Fire Protection Service Corporation in the amount of \$6800 annually. Motion was adopted.

**Discussion Items:** **1. M. L. Pearson** discussed a roll back tax situation in Utah on property that they own and had concerns that those policies might show up in Wyoming. **2. Road and Bridge Supervisor, Matt McCloud and County Engineer, Amy Butler** met with the Commissioners on the MCG Bridge, and adding asphalt decking and an apron. The cost increase would be \$17,251.50 and would be covered by 50% of the grant. The Commissioners took no action on this. **3. South Maintenance Supervisor, Matt Mochel** met with the Commissioners on the Justice Center fire alarms and maintenance service.
