**NOTICE OF HEARING ON PETITION FOR FORMATION OF
NORDIC RANCHES COMMUNITY
WATER AND SEWER DISTRICT**

Notice is hereby given that on the **21st day of May, 2019, at 10:00 a.m.**, at the Lincoln County Courthouse, Commissioner's Boardroom, located at 925 Sage Avenue, Kemmerer, WY, and also via video conference at the Lincoln County Branch Office Conference Room, located at 421 Jefferson Street, Afton, WY, the Lincoln County Commissioners shall hold a hearing on the petition for the formation of the **Nordic Ranches Community Water and Sewer District**. The general purpose of the proposed district is to acquire the existing water system. The initial services to be provided by the district are continued water distribution. The services &/or equipment to be acquired, constructed or operated are the existing system – all wells, distribution lines, holding tanks, meters, easements, water rights, etc. The proposed method of financing the improvements or services to be provided within the first year after formation will be to continue monthly rate billing and also apply for low interest loans and grants.
